to provide our business, on our electronic database, the catalog and pricing information of Kent Automotive. We ("Customer") have granted formal authorization to a representative of Kent Automotive to provide our business with Kent Automotive's catalog and pricing information which includes Kent Automotive's part numbers, descriptions, customer costs and product categories on a suitable media to be made accessible for use at Customer's location.

TERMS AND CONDITIONS (Agreement between Kent Automotive and Customer)

The "Confidential Information supplied to Customer on computer tape is and shall remain the exclusive property of Kent Automotive and is deemed to be propriety property of Kent Automotive. Kent Automotive hereby grants to Customer a non-exclusive and royalty-free license to use the Confidential Information in connection with the Kent Profit Max Program. Customer hereby acknowledges that the Kent Profit Max Program and the Confidential Information of Kent Automotive are proprietary and confidential and therefore agrees to prohibit the unauthorized use of the Confidential Information including, but not limited to use of the Kent Profit Max Program, outside of Customer's ordinary course of business and to prohibit the unauthorized disclosure to any party of the Confidential Information or any portion thereof.

Customer agrees to use Kent Automotive's catalog and pricing information (Kent Profit Max Program) extended by Kent Automotive as a value-added service and further agrees to implement the essential aspects of the program working through Kent Automotive's sales representatives.

In the event of cancellation by either party (Customer/Kent Automotive) of this agreement or of it's participation in the Kent Profit Max Program, the Customer agrees to cease the use of Kent Automotive's catalog and price information and all other Confidential Information, take immediate steps to extract the information from customer's database and Computer Service company's database and immediately return such information to Kent Automotive. Kent Automotive retains the right to remove any storage equipment provided without charge to the customer.

Customer hereby agrees not to sublicense or assign the Confidential Information or the Kent Profit Max Program without the prior written consent of Kent Automotive, which may be withheld by Kent Automotive for any reason in Kent Automotive's sole discretion.

Kent Automotive agrees to supply its catalog and pricing information, through the Computer Service Company, in a suitable media for placement in an electronic database for use by Customer. Customer hereby waives all claims against Kent Automotive for any deficiencies or defects in the computer tape.

The term of this Agreement shall expire on _____ unless extended by a written agreement between Customer and Kent Automotive. Either party (Customer/Kent Automotive) may terminate this agreement thirty (30) days following date of written notice. In the event Customer breaches any term or condition in this Agreement, Kent Automotive shall be afforded and shall have the right to monetary damages and the right to

obtain injunctive relief to restrain Customer from using the Kent Profit Max Program. This Agreement shall be interpreted in accordance with and governed by the laws of the State of Illinois and the United States of America, excluding the body of law known as the conflicts of law.
